RECENT BUSINESS UPDATES

This announcement is made on a voluntary basis to keep the shareholders of Hengxin Technology Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) and potential investors informed of the latest business development of the Group.

APPROVAL FOR SELF-INITIATED NATIONAL STANDARDS FOR COAXIAL COMMUNICATION CABLES

Recently, three self-initiated national standards, namely “Coaxial communication cables — Part 1–107: Electrical test methods — Test for cable microphony charge level (mechanically induced noise)” (同軸通信電纜第1–107部分：電氣試驗方法電纜顫噪電荷電平(機械感應噪音)試驗), “Environmental test methods — Resistance to solvents and contaminating fluids” (環境試驗方法耐溶劑及污染液試驗) and “Coaxial communication cables — Part 1–302: Mechanical test methods — Test for eccentricity” (同軸通信電纜第1–302部分：機械試驗方法偏心率試驗), of Jiangsu Hengxin Technology Co., Ltd. (江蘇亨鑫科技有限公司) (“**Jiangsu Hengxin**”), a wholly-owned subsidiary of the Company, had obtained the approval of the State Administration for Market Regulation and the Standardization Administration of the People’s Republic of China to be registered as three national standards (the “**Three National Standards**”).

The promulgation of the Three National Standards plays a significant role in the regulation of test methods for coaxial communication cables products and promoting the healthy development of the industry. Meanwhile, it further demonstrates the pioneering efforts of Jiangsu Hengxin in the industry to facilitate standardization in the communication cables industry.
